Some 2015 F-150 vehicles equipped with a 3.5L EcoBoost engine and built on or before 4/14/2015 may exhibit an illuminated MIL with one or more of the following diagnostic trouble codes (DTCs): P0060, P0161, P0157, P0054, P0137 and/or P0141.

ACTION

Follow the Service Procedure steps to correct the condition.

SERVICE PROCEDURE

- 1. Connect the Ford Integrated Diagnostic System (IDS) service tool or equivalent to the data link connector (DLC). Are DTCs P0054, P0141, P0137, P0060, P0161 or P0157 stored in powertrain control module (PCM)?
 - a. Yes proceed to Step 2.
 - b. No this article does not apply. Refer to Powertrain Control/Emission Diagnosis (PC/ED) manual for normal diagnosis.
- 2. Are DTCs P0054, P0141 or P0137 present in the PCM?
 - a. Yes replace bank 1 catalyst monitor sensor (CMS). Refer to Workshop Manual (WSM), Section 303-14.
 - b. No proceed to Step 3.
- 3. Are DTCs P0060, P0161 or P0157 present in the PCM?
 - a. Yes replace bank 2 CMS. Refer to WSM, Section 303-14.
 - b. No this article does not apply. Refer to PC/ED manual for normal diagnosis.
- 4. Reprogram the PCM to the latest calibration using IDS release 95.02 or higher. Make sure you are connected to the internet when entering module programming to obtain the latest updates. Calibration files may also be obtained at www.motorcraftservice.com.
