Ford 2018 F-150

**Issue:** Some 2018 F-150 vehicles equipped with a 2.7L EcoBoost engine may exhibit an illuminated MIL with DTC P0471 stored in the powertrain control module (PCM).

**Action:** Follow the Service Procedure steps to correct the condition.

# **Service Procedure**

- 1. Connect the appropriate Ford scan tool or equivalent scan tool and check for DTCs. Is DTC P0471 the only DTC stored in the PCM?
  - (1). Yes proceed to Step 2.
  - (2). No this article does not apply. Refer to the Powertrain Controls/Emissions Diagnosis (PC/ED) Manual for normal diagnostics.
- 2. Replace the exhaust pressure sensor. Refer to Workshop Manual (WSM), Section 303-14A.
